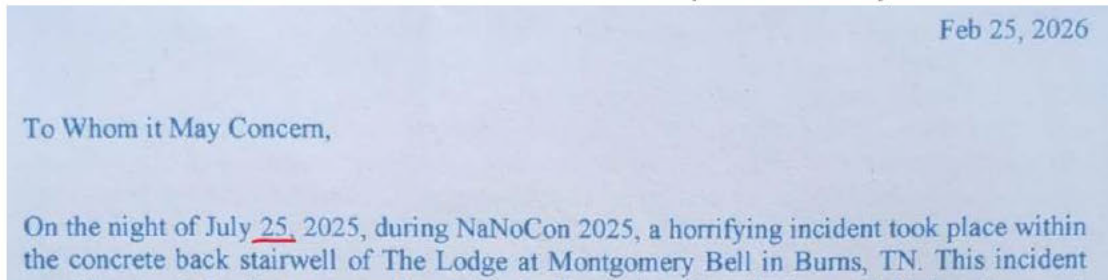

Incorrect. July 25, 2025 was a Friday. The alleged incident took place on Saturday, July 26, 2025.

PRIVACY

Many of us have refused to speak publicly about this situation because Nancy wanted it to be private, we followed her wishes. Many people, including Patti, violated those wishes from day 1. We have kept her privacy as long as possible but at this time, there is too much at stake and too much harm done in Nancy's name.

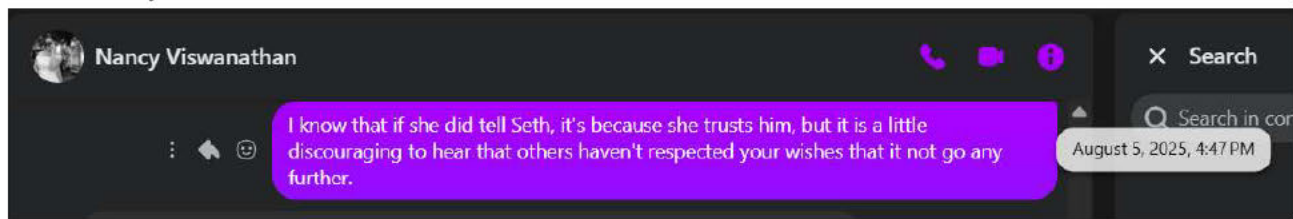

GENERAL TIMELINE

July 26, 2025, Saturday

Night time - NaNoCon alleged incident.

July 27, 2025 Sunday

Before 8AM - Nancy gives a statement about the alleged incident to Elliott Canter and a witness (recorded).

11AM NaNoCon ends.

July 28, 2025 Monday

10:30PM - Patti calls me and shares the allegations (1 hour call)

11:54PM - After the call, Nancy emails KC Gleason a full statement.

July 29, 2025 Tuesday

8:14AM - I contact Nancy, she forwards me the email she sent KC.

Mid Morning - Nancy speaks to KC & John on the phone.

4:00PM - KC & John talk to Elliott on the phone.

6-8PM - Elliott, ACA board/producer and I (at Nancy's request) have a conference call. I used Nancy's email to tell her story.

7:56PM - Nancy emails Elliott a different email than the one KC, John & I got.

After 8PM - After Elliott reads the email, he and Nancy talk on the phone.

After midnight - Call ends.

INCIDENT TIMELINE

JULY 26, Saturday

5-6PM - Elliott approaches Nancy at the bar, she describes him as "a little drunk" and buys him 2 more drinks.

8:30PM - Glenda's Fire Show. I spent dinner (**7PM-9PM**) with Nancy, she had 2 glasses of wine, she appeared sober and clear minded while we talked. After the fire show, Nancy was still clear minded when I left the table. I immediately joined Elliott, my husband and another guest. We chatted for 20 mins, Elliott seemed very drunk at this point. We joked he would not wake up in time for his speech the next morning.

9PM - Dinner ends. People move to the Restaurant/Bar/Lobby (all in one room). My family and I went to an event hosted outside. We returned to our room at **11:45PM**.

9:30PM - Glenda Jordan, Arden Hart and Dr Ben Hamilton observe Nancy aggressively kissing Elliott while he attempts to turn away from her kissing. Glenda considered intervening, until Nancy & Elliott got up and walked away together.

10PM - Glenda texts Arden (who walked away momentarily) stating Elliott and Nancy seemed to be NOW engaging in a consensual encounter, whereas previously they both perceived the encounter as one sided, with Nancy having initiated and Elliott looking uncomfortable, pulling away.

UNKNOWN - After Glenda observes them walking away, Nancy and Elliott walk outside together, come back in, still cozy, and go back to the bar.

11PM - An anonymous witness tries to get Elliott away from Nancy, fails and leaves.

11P-12:00AM - Sometime within this hour, Elliott and Nancy end up on the stairwell.

12:15AM-12:30AM - Chad Harris helps Elliott look for the wallet. Dr Ben joins them.

12:25AM to 1:01AM - Elliott and Dr Ben look around for Elliott's wallet.

UNKNOWN - It is not known exactly where Nancy was for those **45+** minutes, but she was texting Elliott during that time.

12:55PM-1AM - **W1*** runs into Nancy in the hallway. Nancy states she just came out from the stairwell and alleged she had been attacked by Elliott moments before, despite not having been with him for at least 45 mins prior.

JULY 26, 2025 Saturday

5-6PM - After speeches end:

It was mid-afternoon in the lobby of The Lodge when I was approached by Elliott Martin (aka Secular Rarity). We had met in person for the first time briefly while attending the Ark Encounter protest in Kentucky only a couple weeks prior. We got to chatting, and since we were right by the bar, I offered to buy him a drink. He already seemed a little drunk, but I wasn't going to police him. After two drinks, our conversation turned towards flirtatious, at

July 26, 2025 Saturday - 9PM - Dinner Ends. People go to the bar. At the bar:

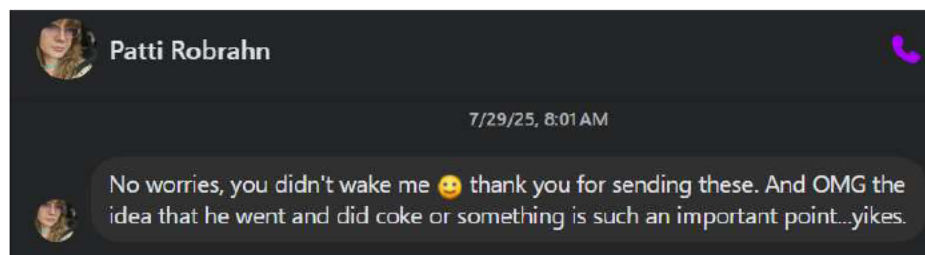
point, I felt bold enough to tell him how cute he was and that I did have a bit of a crush on him. I noticed he was extremely drunk and/or on some kind of mind-altering substance because he was sweating profusely and talking erratically. He seemed surprised yet delighted by my admission and said he had no idea. He grabbed my hand and began leading me around to the various groups of people within the lobby and on the deck outside. Though I couldn't understand his incoherent interaction with others, I just laughed because I was having a great

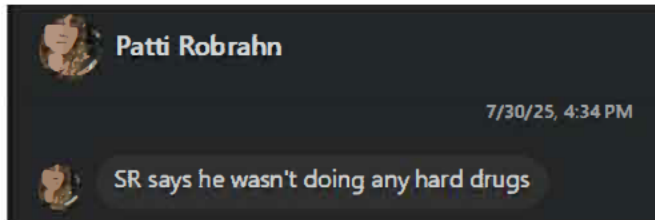
These accusations of drug use are likely meant to disparage Elliott's character.

Nancy, Patti and I discussed the possibility of drugs being involved. It was ruled out.

Nancy knew Elliott was, in her own words, "extremely drunk". She admits to purchasing several drinks for Elliott herself.





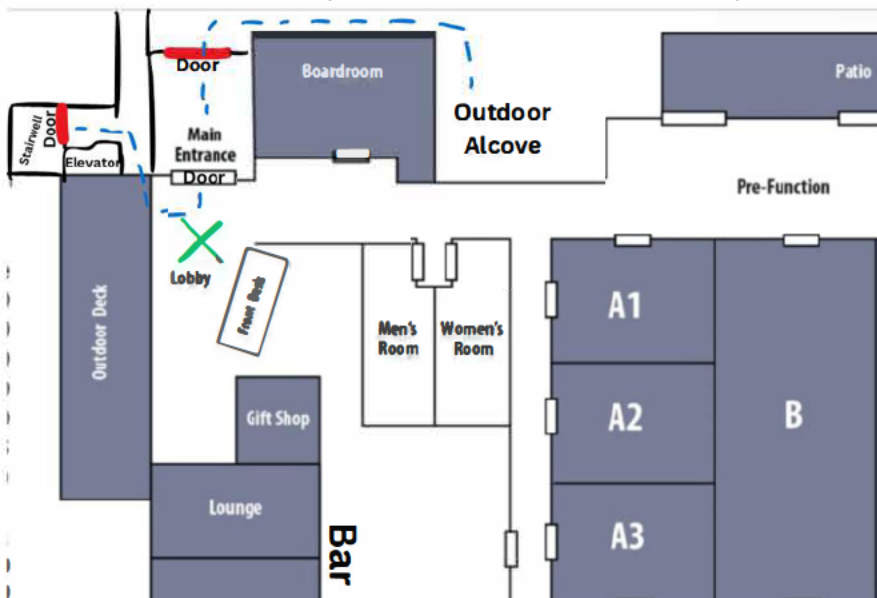
time. He then abruptly pulled me out the front sliding doors of the hotel. I went willingly as I didn't believe I was in any kind of danger. I trusted him and considered him my friend, though I was unsure of what he was doing when all our other friends were inside. Once outside, this is when he said he knew I was married yet continued to shove me into the darkened alcove behind the door and kissed me aggressively, then stumbled and knocked us both to the ground.

I helped him up, but the moment I did, he took my hand once more and led me through a different door that led to the back stairwell. I was still tipsy and not quite registering what we

Nancy says at this time she was "tipsy" and Elliot was "extremely drunk". She seems aware of the enormous difference in intoxication levels. Several witnesses described Nancy as sober and clear headed all night, and Elliott as falling down drunk. Reverse the gender roles for a moment.

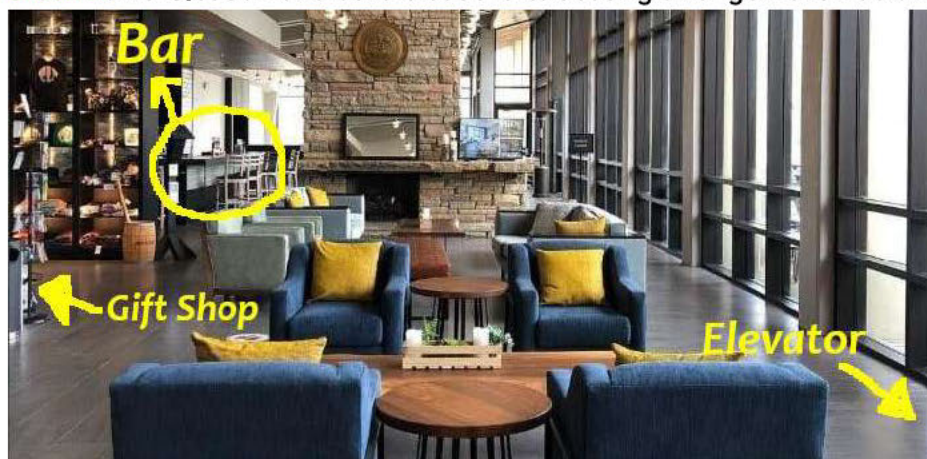
To reach the stairwell from the alcove, they had to walk through a total of 3 doors, through the Lobby, in front of many people. Those in the lobby, main desk and bar would see them. People in the Lobby: John & KC Gleason, **W1*** & Drew Bekius, Glenda Jordan, Arden Hart, Dr Ben & anonymous witness. *Witness 1

Nancy claims she was taken from the alcove to the stairwell, however, witnesses observed Nancy and Elliott come back into the lobby, to the restroom and back to the bar, engaging with John Gleason, KC and others. (KC's witness statements below).



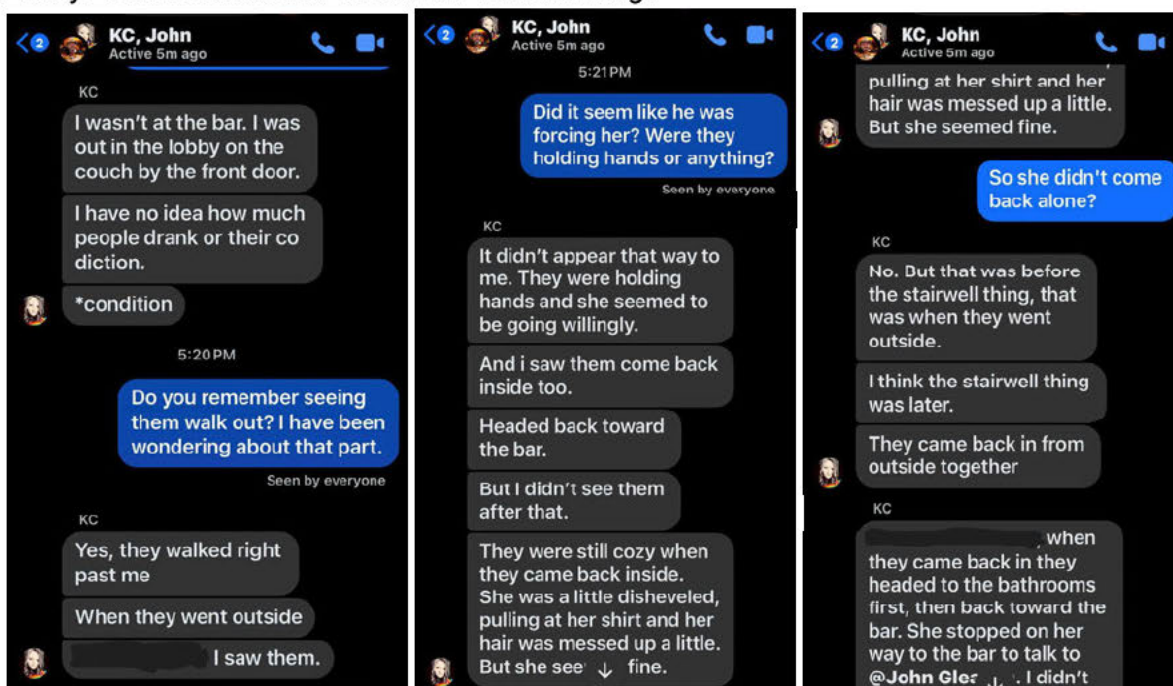
Blue dashes indicate the path from the alcove to the stairwell.

Witnesses reported Nancy and Elliott came back inside from the front doors and went to the bar, **NOT** to the stairwell. This happened later. KC Gleason (who does not drink) was on a seat near the Lobby Entrance door and witnessed the following:



CNC & “COCK APPREARANCE”

Nancy and Patti’s defense for discounting witnesses relies on claiming Elliott manipulated Nancy AND the community. The following screenshots indicate that, from day 1, Nancy told different versions of the story to different people at the same time, **BEFORE** she spoke to Elliot on the phone (where Patti says the manipulation first happened).

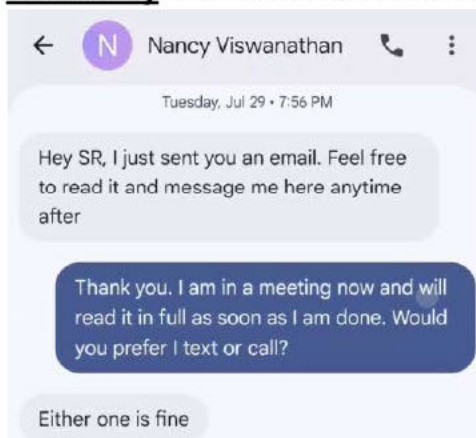

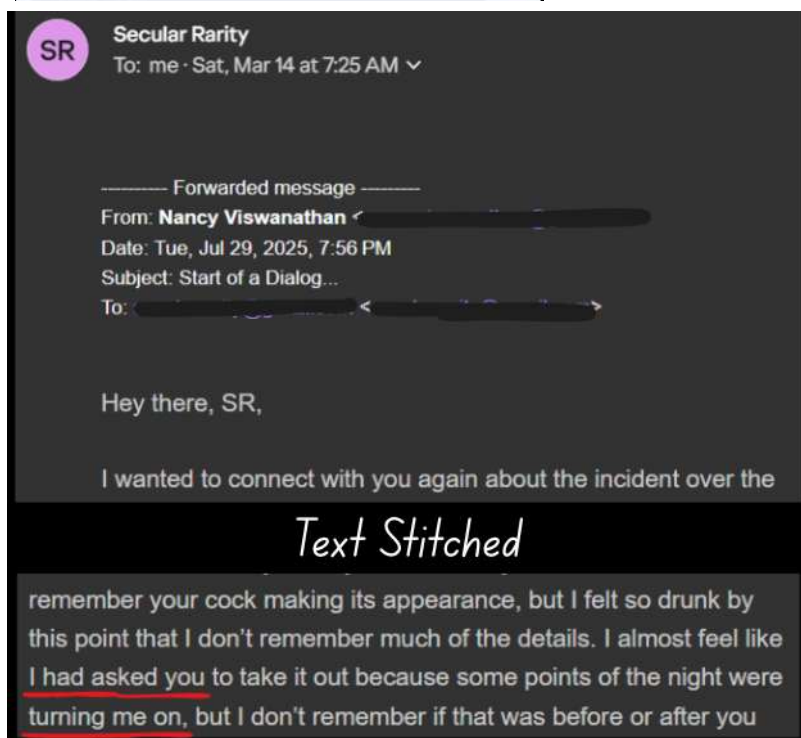
7:56PM - Nancy emails Elliott (SR) a statement, some parts are similar to the email sent to KC & John.

The following parts are vastly different and not mentioned at all in KC's email. This was sent **BEFORE** Nancy spoke to Elliott after NaNoCon.

Patti has claimed Elliott manipulated Nancy's memory on that first call and then manipulated everyone in the community, convincing her that she consented, but these words came **from Nancy**. Her first contact with him about the incident came several hours after the email:



After 8PM - When Elliott's meeting ends after 9PM, Nancy and Elliott talk on the phone for 3.5 hours. This corroborates the email was sent **BEFORE** she had any contact with Elliot about this incident:

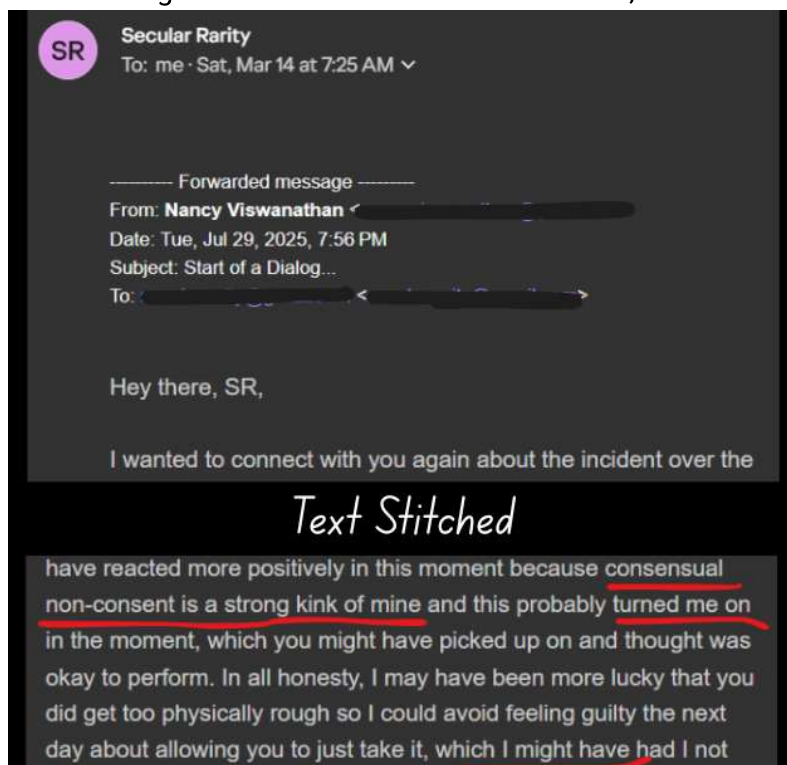


Nancy's statement indicates she was not opposed to Elliot's penis "making an appearance".

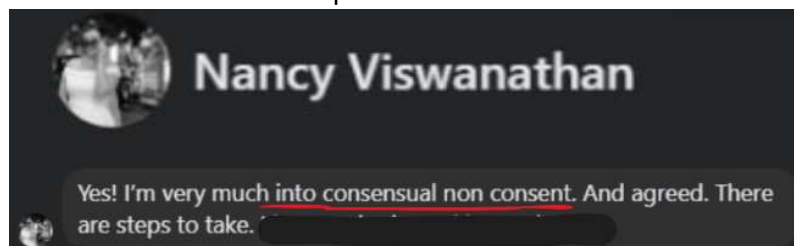
Nancy describes walking into the stairwell and immediately being pushed down the stairs as they were going up, her shirt pulled up, then going back up the stairs and getting choked. It is unclear at what point she asked him to pull out his penis if the alleged attack began immediately upon entering the stairwell in the way she describes.

There is no indication that kink, CNC or BDSM was involved in the incident, however, Nancy did bring up this topic to Elliott and several others at NaNoCon, then denied being into it in the letter, the following is not to shame her for her interest, but rather to show the inconsistencies.



Patti and Nancy have both publicly denied Nancy being into Consensual Non-Consent (CNC). However, Nancy confessed this to several people including: Elliott (SR), Helen, Bre, Glenda Jordan and discussed it on the ApostateSisters channel with Patti.



August 1, 2025

Nancy and Patti recorded a show about Kink. In this video, Nancy makes a “confession” about CNC (**1 WEEK** After NaNoCon). Video at: <https://tinyurl.com/KinkCoachVideo> (60 secs) In the video Nancy and Patti admit discussing the topic of CNC “at length”. Being into Kink is perfectly fine! Publicly lying about it repeatedly to protect yourself is not.

This came from **NANCY** every time. Patti and Nancy have denied this publicly, except in the video and in several messages. CNC does not negate harm can happen, but it’s inconsistent with their public claims.

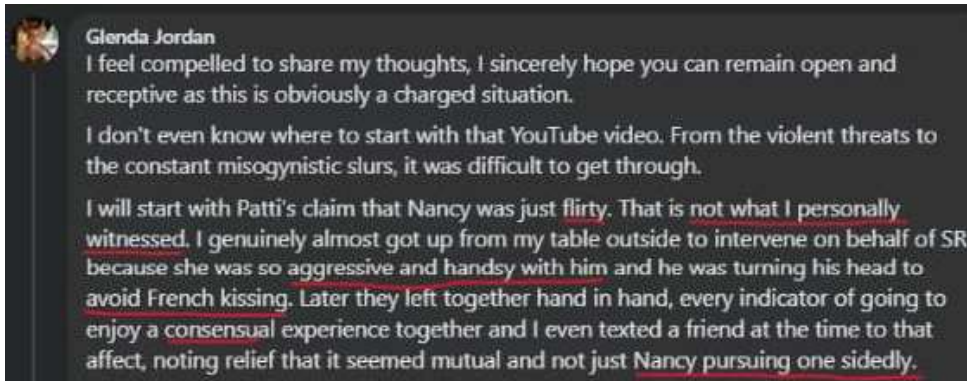

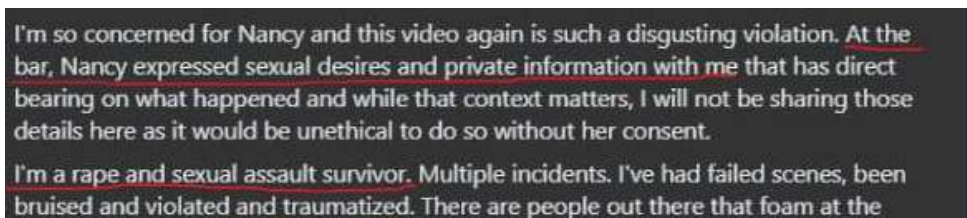
CONSENT

Witness accounts and lobby footage indicate things went beyond "harmless flirting", crossing physical boundaries. Nancy pursued Elliott at the bar, aggressively kissed him while he attempted to turn away from her.

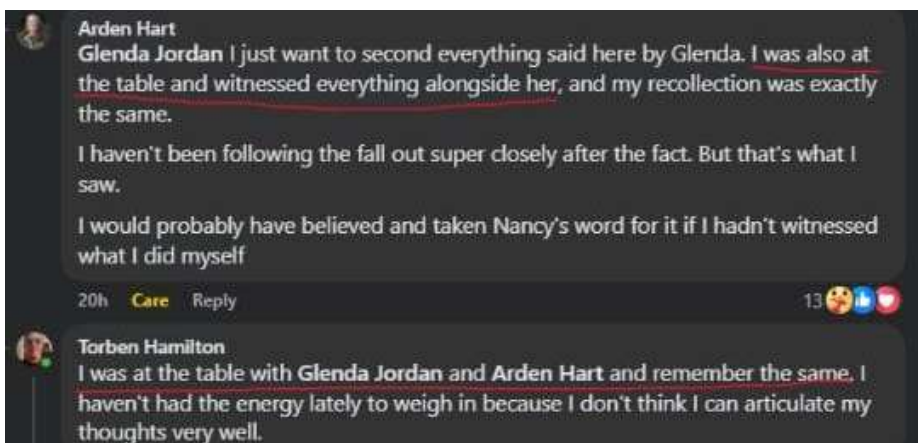

I feel compelled to share my thoughts, I sincerely hope you can remain open and receptive as this is obviously a charged situation.
I don't even know where to start with that YouTube video. From the violent threats to the constant misogynistic slurs, it was difficult to get through.
I will start with Patti's claim that Nancy was just flirty. That is not what I personally witnessed. I genuinely almost got up from my table outside to intervene on behalf of SR because she was so aggressive and handsy with him and he was turning his head to avoid French kissing. Later they left together hand in hand, every indicator of going to enjoy a consensual experience together and I even texted a friend at the time to that affect, noting relief that it seemed mutual and not just Nancy pursuing one sidedly.

THE STAIRWELL

July 26, 2025 Saturday

Nancy claims Elliott dragged her from the outdoor alcove to the stairwell where the alleged incident took place. She followed SR up the stairs and came out the door to the lobby between **12:55 and 1AM**, at this time she ran into **W1*** minutes after the alleged attack. *Witness 1

The exchange below between Elliott and Nancy does not line up with that description:

	From Elliott's phone, the following are the timestamps for the texts: 12:25AM - Elliott: Nancy! You and I need to talk! Nancy: I'm in the same spot Elliott: I'll find you. I need my wallet 12:28AM - Nancy: Come outside. 12:38AM - Elliott: Please lol come to the front Lobby. 12:55AM - W1* runs into Nancy. *Witness 1 1:01AM - Elliott: Are you in the Lobby? Elliott recalls being in the stairwell before looking for the wallet. He and Dr Ben looked for the wallet in the stairwell.

"Come to the lobby" at **12:38AM** and "Are you in the lobby?" at **1:01AM** suggests they never found each other between those times.

Chad Harris helped Elliott look for his wallet from **12:15AM** to around **12:30AM**.

Chad I was high as fuck, but I remember helping SR look for his wallet 🤔
Chad Nah. He was definitely drunk/high/something. I had him empty his pockets and gave him a pat down. After we failed to find it in the dining area, he was like "It's okay man. It's just stuff. Everything can be replaced..." And proceeded to wax drunkequent about the temporal nature of cash and shit
Chad I was like "You should probably get some sleep."
Chad replied to you You don't happen to have any exact time of what time you helped him? Lik... I know I went back to my hotel shortly after that. I apparently plugged in directions at 12:38 AM. So it would have been about 12:15 I reckon.

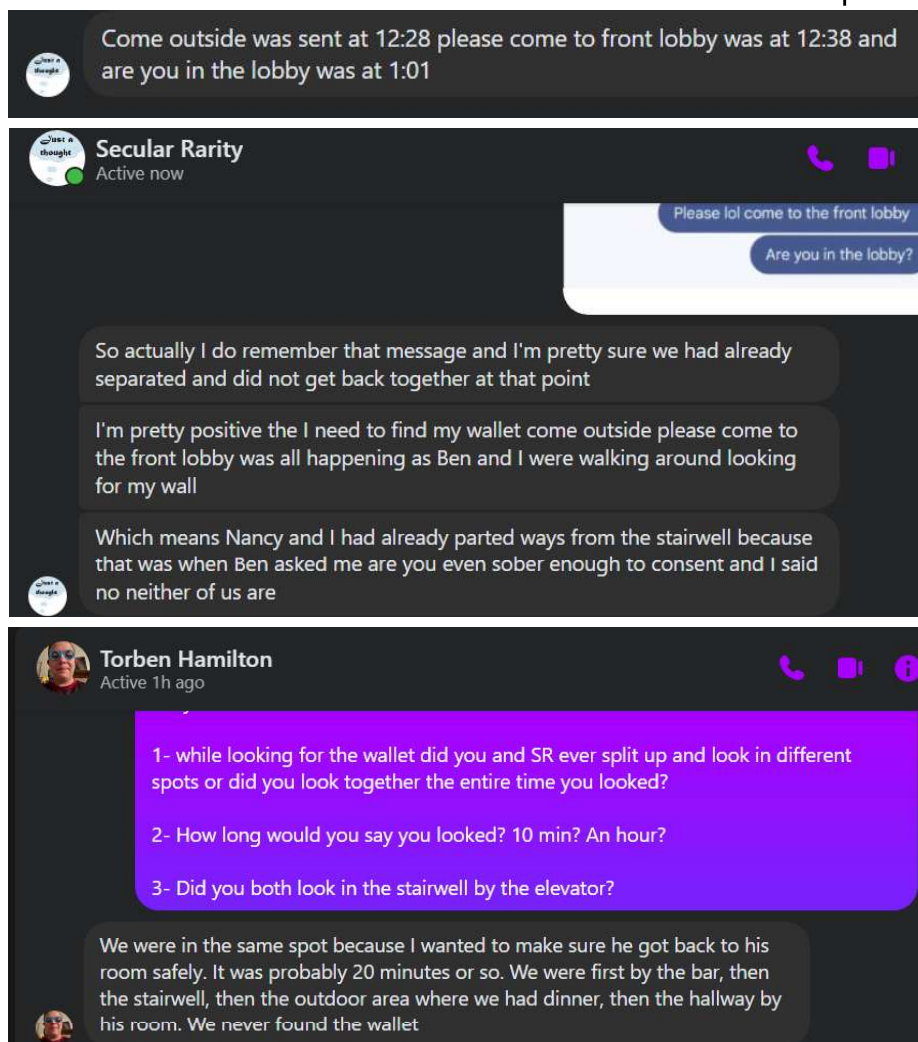
Elliott and Dr Ben looked for the wallet while Elliott and Nancy were texting. Dr Ben stated he and Elliott did not separate during this time and Elliot stated he went to bed after looking for the wallet with Dr Ben.

Dr Ben stated he and Elliott looked for the wallet in the stairwell at some point between **12:25 and 1AM**. Nancy was not there. It is unclear where she was during that time.

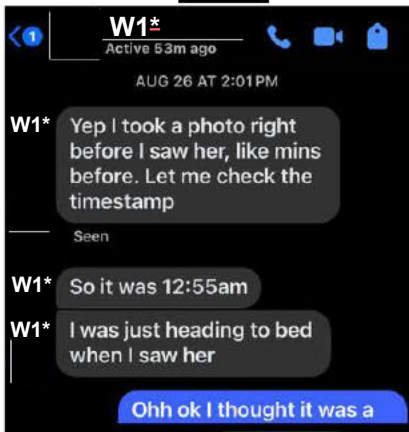
According to the evidence above, Nancy and Elliott's stairwell encounter happened before **12:15AM**.

The texts and witness accounts indicate Elliott was not with Nancy between **12:15AM - 1:01AM**.

12:55-1AM - W1* runs into Nancy in the Lobby's hall.

Nancy does not make it clear what she believes Elliott's motivation for the completely unprovoked alleged assault was.

Below Nancy states the push down the stairs was likely accidental. Elliott recalled they both shoved each other against walls, passionately, and he fell down the stairs with her, but unsure of how exactly that happened due to intoxication levels that led to blackouts. Earlier in the letter, Nancy described him falling down in the alcove because he was so drunk and unsteady on his feet.

Nancy follows her alleged attacker up the stairs. After the first push/fall down the stairs, they were next to the door where they entered the stairwell, which led back to the lobby (same level as the alcove).

Once we both reached the platform of the steps halfway up, he spun around yet again... and STRANGLED ME WITH BOTH HANDS! This lasted several seconds, long enough for me

Nancy describes a second attack for no apparent reason while she was following him up the steps.

After the second alleged attack at the platform, Nancy states she followed Elliott up the stairs and out the same door he exited.

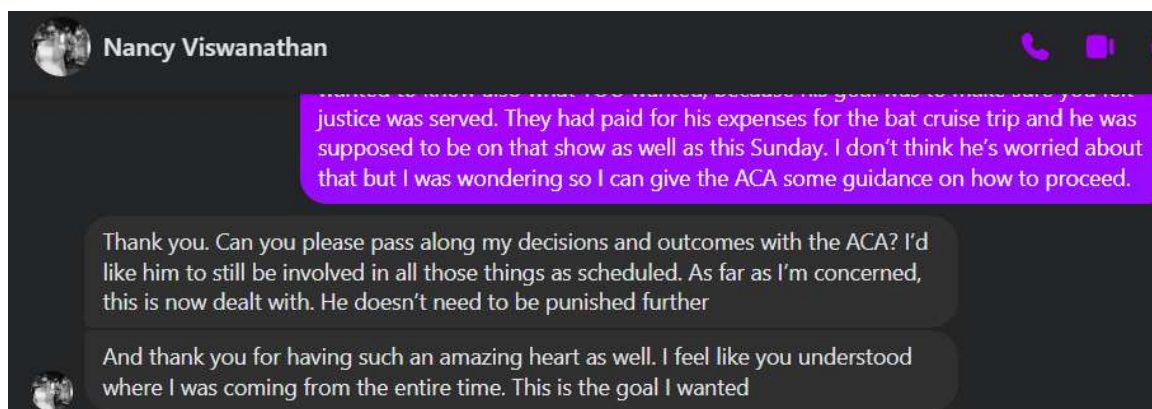

I felt obligated to warn women I felt close to at the time to ensure they kept their guard up around him. When tragedy occurs, it can often bring people closer, and these conversations did

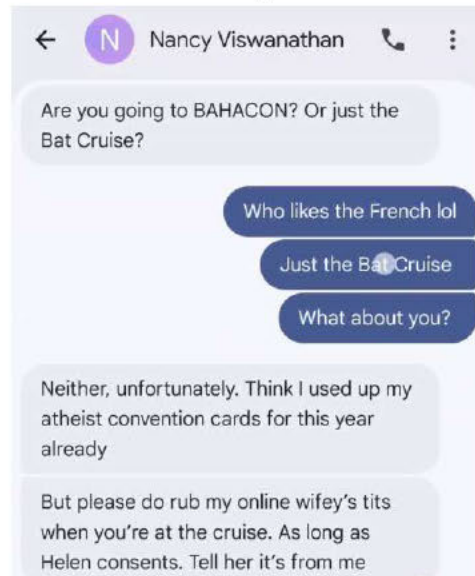
Nancy told several women it was safe to share a house with Elliott in Austin the weekend of August 16, 2025 for the ACA's "Bat Cruise". She also asked ME to tell the ACA she wanted Elliott to continue working with them and attend this in-person event.



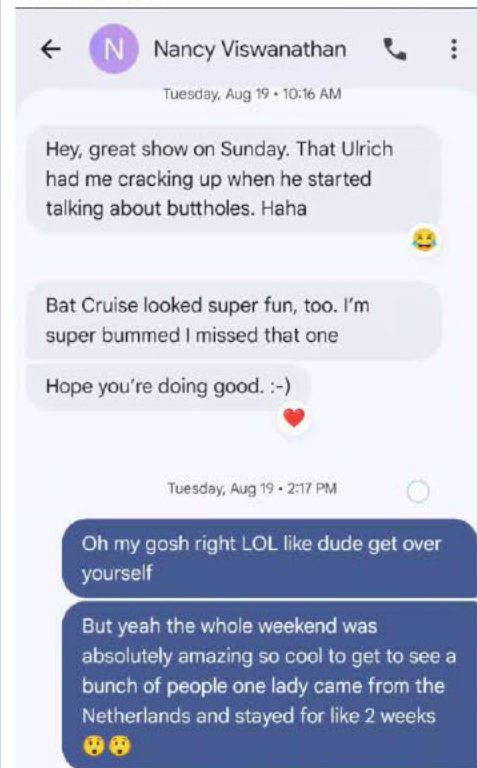
For the next few days, we had some kind of interaction daily, either through texts or phone calls. I wanted to ensure he was checking in with me, so I kept the dialogue going by asking how his day was or sending pictures of something I was doing that day. And not one of these conversations were of a sexual nature. Though much of the interaction was great, one of the

Nancy and Elliott discuss the Bat Cruise on August 5, **a week** after the alleged incident. Nancy asks Elliott to **rub Helen's breasts**. This indicates she did not consider him a danger to other women.

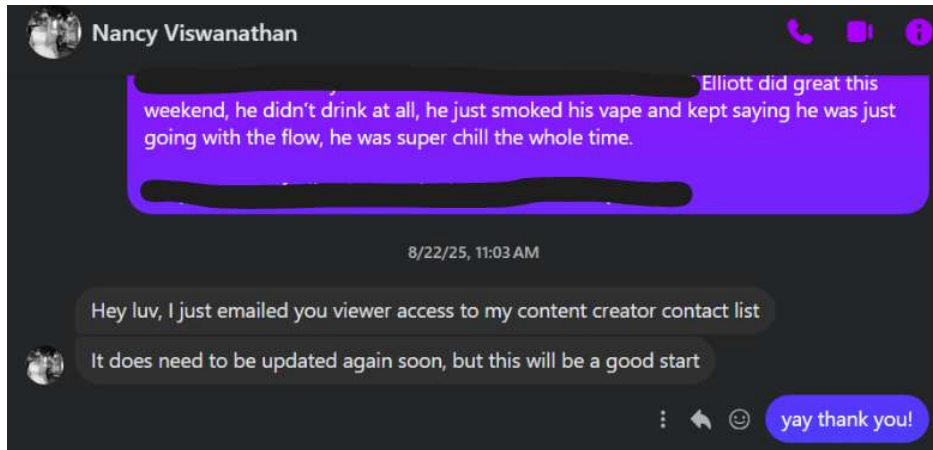

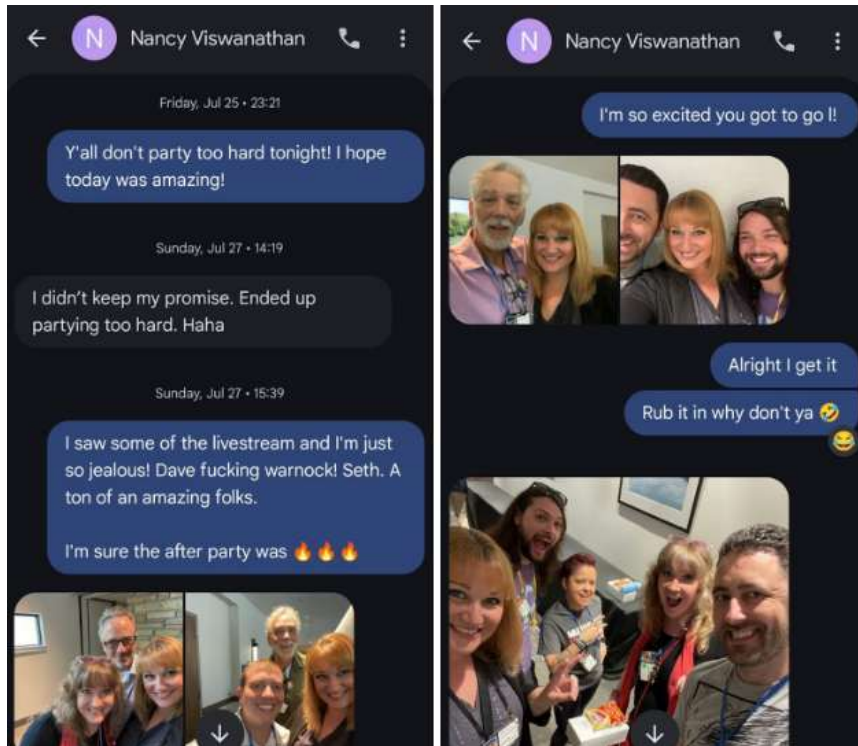
Another revelation that cemented my decision to press charges was another victim of Elliott's who came out. All this time, Patti was working diligently, with my consent, to ensure her sister

This is irrelevant. If we're going to discuss patterns but not give evidence... There are 5 people Nancy approached attempting to engage in sexual encounters at past conferences. 3 men at different in-person gatherings and 2 women at NaNoCon before approaching Elliott, she also offered to have a threesome on 2 occasions.. Until these individuals come forward, it's hearsay in the same way Nancy's "another victim of Elliott's" is hearsay.

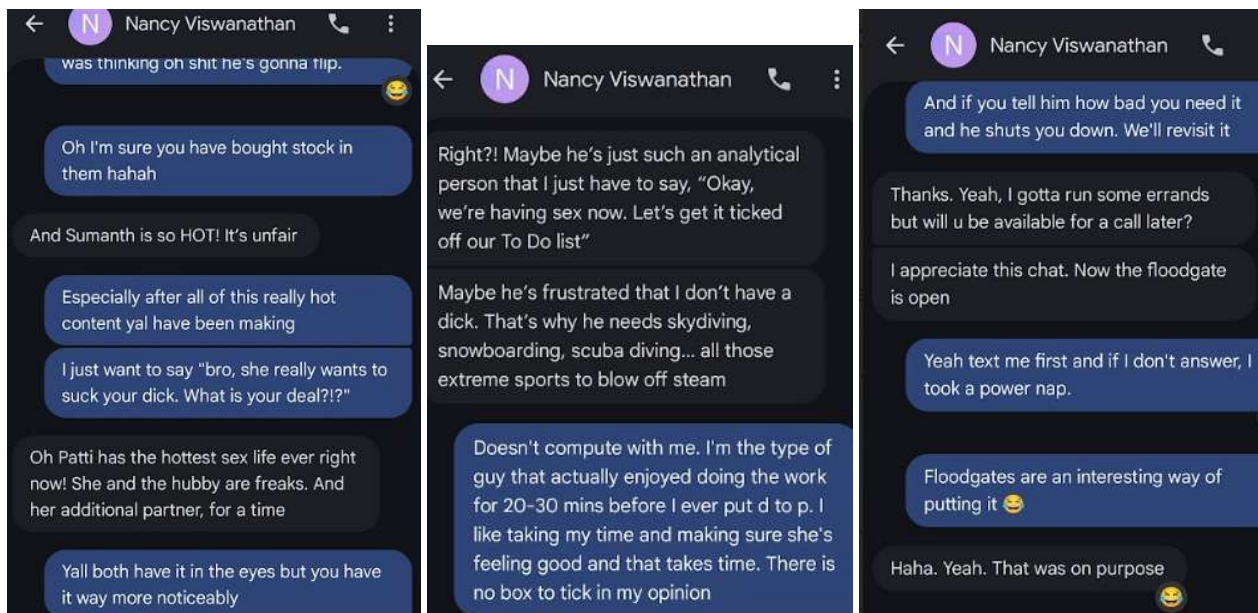

Flirtation and physical sexual contact are completely different things. Glenda Jordan, Arden Hart and Dr Ben described Nancy initiating the aggressive kissing. There is no problem with describing a non-consensual allegation of harm during an otherwise consensual sexual interaction and separating the two.

If the footage is from the lobby, authorities would have timestamps of many of the night's interactions and movements. They would potentially see Ben, Elliott & Chad walking around, Nancy and **W1*** meeting near the lobby, Nancy and Elliott walking toward the stairwell and out the front door. It would show where Nancy went after the stairwell, Nancy kissing Elliott at the bar, etc.

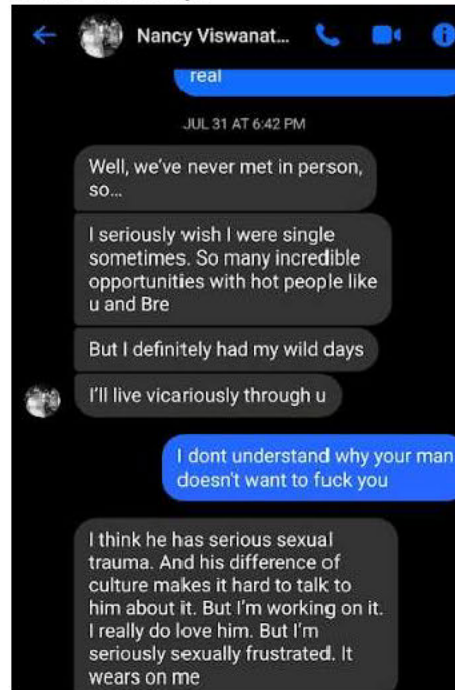

"Close to cheating" suggests the encounter was consensual on Nancy's part.

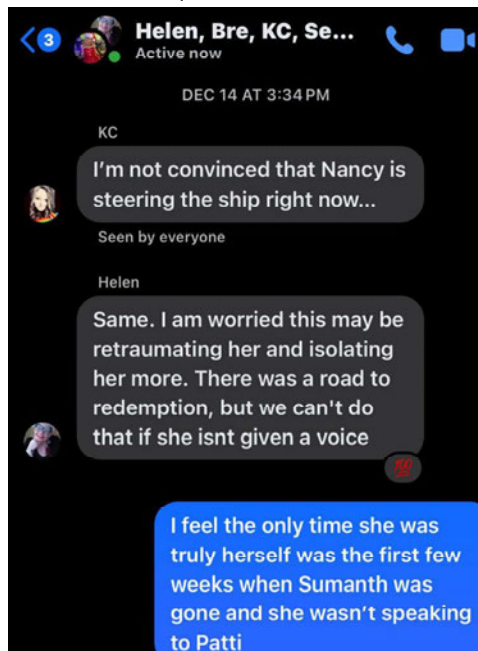

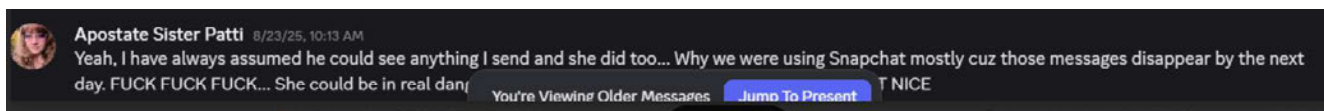
December 14, 2025:



My husband and I tried to move on with our lives and forget this. We even removed every connection to the atheist community I had on every social media platform so I could have some peace of mind, and I stopped recording on my channel with no plans to return. This didn't stop

Patti claimed Nancy's husband removed her access to communication, but later said Nancy removed herself from the community.

Patti told some people that Nancy was safe with her husband, while at the same time pulling several people into a group chat called "Nancy's Safety" and accusing the husband of being controlling. The letter states "WE" removed connections to the community. Given the different accounts, It is unclear how and why Nancy left the community.

The first day I talked to Nancy after I was informed of what happened at NaNoCon, I told her I hoped Elliott (SR) was hurting. I shared a private story about hurting a loved one years ago. I said my conscience was hurting and I felt horrible, so I hoped SR's conscience hurt in that sense. I did not know the full details of the alleged incident at the time I sent this message:



The text I sent Nancy (after the police investigation closed) referred to that conversation. It was meant to say if our conscience hurts, we are more likely to do the right thing because we care. I urged her to tell the full story, because she had left a path of destruction. I was hurt by her using me and had a human reaction.

I have provided screenshots throughout this document indicating Nancy initiated the sexual encounter and had consensually crossed physical boundaries, suggesting her desire to engage in a sexual encounter with Elliott. Many of us were aware of this and followed her wishes of discretion before she cut us off and accused us of "hiding" things to protect Elliott. We have remained quiet to protect Nancy's privacy.

When I showed my husband the text, he responded to AJ directly and told her to leave his wife alone and that my sexual past and preferences had nothing to do with the criminal acts committed against me. Though I don't know what was said back, I know his phone was flooded with messages I had sent to all of the parties listed

Her husband's phone was not "flooded with messages". I sent ONE text response with screenshots of conversations between myself and Nancy to show I wasn't making things up.

I do regret this, I own my wrongdoings. When I sent that message I was affected very negatively by Nancy's behavior and felt it was the right thing, at **THAT** time. Explanations are not excuses.

husband to leave me. They actually told him that I liked men to rape me! I suddenly knew exactly where all this came from. I remembered telling Elliott during one of our calls that I help women on my channel through their sexual trauma by suggesting they read dark erotica books in the genre of "consensual non-consent." I've found that reading this type of literature has helped me before when trying to reclaim my autonomy from a religion that taught me that my body was not my own, though not something I had ever done in real life or would ever do outside of my own husband. I made the connection... and realized I had far underestimated just how low Elliott would go to protect himself. He convinced my "friends" that I was actually the one who wanted some weird sexual rape fantasy and that he was just giving me what I wanted that night. It was beyond gross to hear.

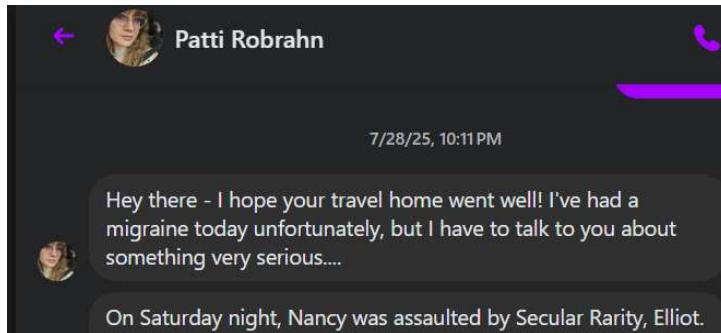

NONE of this information came from Elliott, it came from NANCY, who has admitted this publicly on her own channel and privately to SR, Helen and Bre.

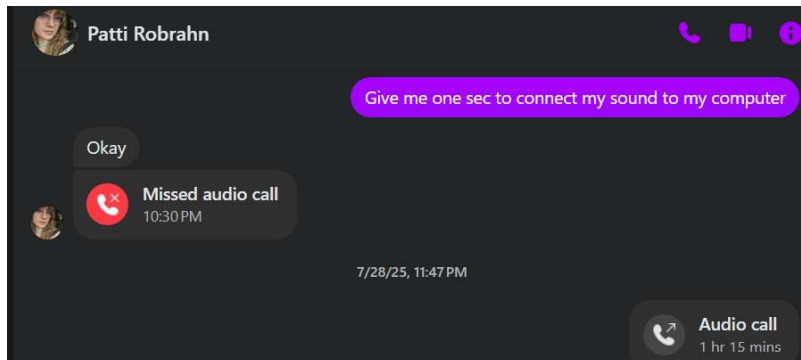

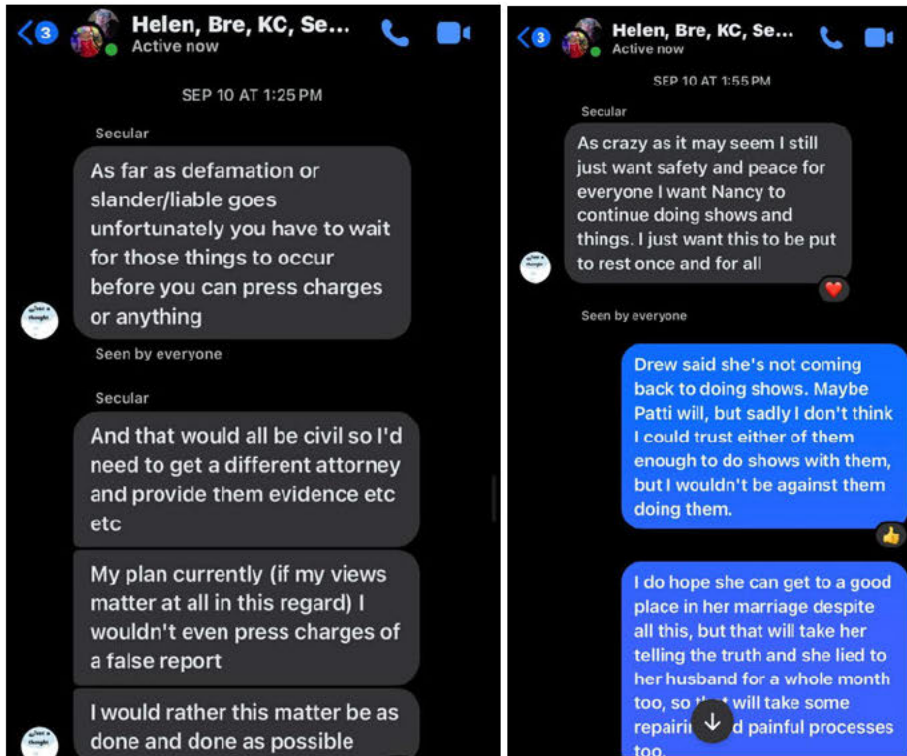
CHARGES AGAINST NANCY

August 22-30, 2025 - According to the screenshots in Nancy's Safety section of this document, Nancy's husband seems to have found out on August 22nd that something had taken place. Patti indicates that's when he cut off her contact with the community. Patti, Helen, Bre, Ember and Maya continued making plans to get Nancy to safety until August 30th. That day, Patti told them Nancy was now safe (with her husband) and suddenly stopped speaking to them.

September 1-2, 2025 - Nancy filed a report with the Tennessee Park Rangers, the investigation was assisted by the Dickson County Sheriff's Office.

September 10, 2025 - Investigation closed and false report charges were offered against Nancy.

After the case was closed, Patti stated on Jay Bundy's stream that there was no video footage from the hotel and no false report charges considered against Nancy. The DA did offer to file false report charges against Nancy. After Elliott declined to file charges, the case was closed, but people around Nancy continued to spread false information and threats against witnesses. We suggested Elliott ask his lawyer whether the DA would be willing to reopen the case and file the charges originally offered. Email from Elliott's lawyer after the case was closed:



MY CLOSING STATEMENT

Seeking appropriate justice for alleged victims considers many factors: victim statements, witness accounts, photos, videos, texts, emails and other forms of evidence.

When Elliott told people to “believe Nancy”, it was because he had no memory of many parts of the night (alcohol-induced blackout), it wasn’t an admission of guilt, it was a plea to believe victims. None of us had reason to question Nancy’s statements at the time he said it.

This document is not denying individuals got hurt. We know both got physically hurt, but how that happened, matters. According to Nancy, most of the night, she was less intoxicated than Elliott (her being “tipsy” vs him being “extremely drunk”). Witnesses confirmed this to authorities. A “tipsy” individual purchased drinks for and initiated a physical sexual contact with an “extremely drunk” individual.

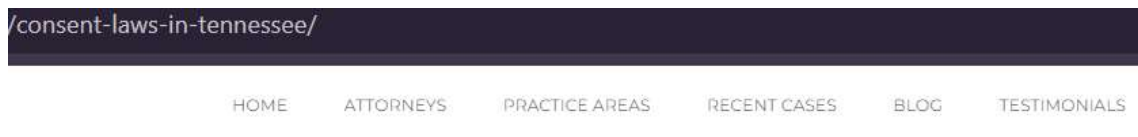

At the time Nancy began to kiss Elliott in the lobby, according to her and all other witnesses, he did not have the capacity to consent, as he was severely intoxicated (described as incoherent and unstable on his feet, even falling outside). Nancy initiated the sexual physical contact in the lobby and recalled feeling she had asked Elliott to pull out his penis in the stairwell, indicating she was giving active consent.

Nancy **NEVER** described Elliott coming in contact with her genital area. She has never mentioned him unbuttoning her pants or putting his hands inside them. When Nancy describes her shirt being pulled up, she never claims he touched her breasts or genitals.

Nancy **DID** describe she felt she had asked Elliott to pull out his penis, she bragged to Helen and Bre about having touched it. Aside from kissing, the only sexual contact in this encounter appears to be Nancy touching Elliott's penis.

Nancy gave us all the impression that Elliott stopped and left as soon as she gave clear verbal removal of consent, even if the behavior was rude, it did not appear to be criminal.

The allegation that Nancy was "thrown down the stairs and choked" is also unclear because Nancy stated to some that it was an accidental fall, which makes sense, since she describes Elliott falling down and knocking her over in the alcove, indicating he was not stable on his feet due to his level of intoxication.

This document reveals several false statements about witnesses, which seem to attempt to make our statements less credible. The document demonstrates Nancy intentionally told different versions of the story to different sets of people (including authorities) **at the same time, from day one**. Our understanding was that Nancy was protecting her marriage and safety, we followed her wishes for privacy. Patti and Jay Bundy made her story public, against her clearly stated wishes.

Trauma is complex. I do not deny Nancy experienced something that night. An accidental fall which leads to physical injury can be traumatic. The shame of social stigma, fear of a husband's wrath, or the idea of being humiliated can all be traumatic. Actions taken in order to preserve your safety at home can be traumatic in itself.

In the secular community we should value accountability, honesty and fairness. There is no question Elliott made the mistake of getting drunk at a public event, he has never denied it and has faced appropriate consequences: he was removed from his volunteer positions at NaNoCon, removed from speaking appearances, and underwent therapy.

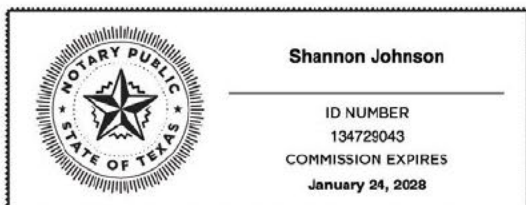
